"Shall Saunders County School District 0039 (Wahoo Public Schools) in the State of Nebraska (the "District") issue general obligation bonds of the District in an aggregate stated principal amount not to exceed Twenty-six Million Dollars (\$26,000,000), for the purpose of constructing buildings, additions and improvements on the existing middle school and high school campus and providing the necessary furniture, equipment, and apparatus for such buildings, additions and improvements; such bonds to be issued from time to time, to bear interest at a rate or rates and to become due at such time or times as may be fixed by, or at the direction of, the Board of Education; and

"Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of and interest on such bonds as the same become due?"
