- Appointed Administrative Staff of the County Board (Public Works Director, IT Administrator, Emergency Management Director, Planning & Zoning Administrator, Noxious Weed Director and Veteran Services Officer)
- All County Employees that are classified as Non-Bargaining Employees

Said 4% wage increase will be retroactive back to July 1, 2023.

The recently appointed Director of Facilities & Grounds will not receive the 4% on his new position wages; Public Defender will not receive the 4% as he was newly contracted May 1, 2023 and the Deputy Public Defender will not receive the 4% as he was not employed until July 3, 2023.
